




This chart shows the total general purpose revenue Vista Norte Public Charter expects to receive in the coming year from all sources.



California's 2021–22 Budget Act, the federal American Rescue Plan Act of 2021, and other state and federal relief acts have provided local educational agencies (LEAs) with a significant increase in funding to support students, teachers, staff, and their communities in recovering from the COVID-19 pandemic and to address the impacts of distance learning on students. Vista Norte Public Charter School was able to engage its educational partners through the use of Google Meets and Zoom. Parents were notified in English and Spanish of the meeting through L4L Connect, email, text message, and telephone calls. A meeting was held on 11/19/2021 to share the 15% increase in LCAP funding, which is an additional \$261,413.00 to support students. During the meeting, the increase in funding was shared and feedback was requested from parents on how the funds could be spent. Teachers and staff present during the meeting were also provided with the opportunity to provide their input.

Additional funding sources were shared with our families and educational partners. ELO was shared on 4/20/21. Educational partners present at the meeting were given an overview of the grant funding, the amount of the funding, the timelines for the grant, and the description of services that are planned to be increased. At that time, feedback from partners was elicited. We plan to share the Educator Effectiveness Block Grant, (EEBG), and the A-G grant funding at our partnership meetings in January 2022.

Vista Norte Public Charter School is a charter school serving an unduplicated population over 55%. The additional funds will be used to specifically add more teachers and staff identified in our LCAP:

- LCAP Goal 2, Action 4 will be increased by \$152,839 to hire additional teachers.
- LCAP Goal 3 Action 2 will increase by \$110,000 to hire an additional counselor.

These increases to these actions are in addition to the initial allotment of supplemental and concentration funding provided to the school. These funds are principally directed at meeting the identified needs of our low-income, English learner, and foster youth students. Additional funds are slated to be allocated to school safety through enhanced COVID-19 cleaning, purchase of safety barriers and equipment such as masks and cleaning materials.

Vista Norte Public Charter School is actively implementing its Local Control and Accountability Plan. The attached Mid-Year Report shows specifically how funds are being expended for each goal and every action in the LCAP.

This year, we have hired additional staff aligned to following LCAP goals:

- Two FTE staff LCAP Goal 2 Action 4
- We currently have positions open for the following: English Learner paraprofessional LCAP Goal 1 Action 1, School Counselor LCAP Goal 3 Action 2

We are implementing our Safe Return to School Plan that is reviewed and adopted by the Vista Norte Public Charter School Board twice annually (or as State mandates necessitate) and was last revised in December 2021. Various funding streams are being allocated to execute and maintain the plan, including monthly safety walks, professional development, community workshops, and additional intervention programs. The plan is reviewed and updated as necessary to meet state and local requirements.

Our Educator Effectiveness Block Grant, A-G Grant, and the Extended Learning Opportunities grant are aligned to our Local Control and Accountability Plan. The EEBG is linked with LCAP Goal 2 – Action 2 regarding professional development. For example, we have secured both internal and external professional learning engagements to drive progress across all four LCAP goals. Teachers, tutors, instructional coaches, counselors, and administrators each have professional learning designed to build expertise and capacity. The ELO is supporting LCAP Goal 1 – Actions 2/3 with extended learning opportunities, so that all students can reach their goal of earning a diploma and create a post-secondary plan. The A-G Grant aligns with LCAP Goal 2 Action 4 in supporting teacher efforts to meet the needs of unduplicated students and meet state standards.

We did not receive ESSR III funds.

# **Plan Summary [2022-23]**

### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Vista Norte Public Charter School is a Dashboard Alternative School Status (DASS) school, with a Transitional Kindergarten through Grade 12 (TK-12) independent study program. Our current enrollment is 692, and we serve 28.2% English Learners, 84.2% low income, 1.1% foster youth, and 12.3% Special Education students. We are a charter school that serves a diverse student community with the mission of engaging students in learning, who are no longer enrolled in a traditional classroom program, or who prefer a personalized learning education in an alternative setting. Our goal is to successfully prepare students for work or college readiness through our integrated and personalized program of job readiness coursework and standards-based curriculum. Some students need the flexibility of an independent study model to meet family obligations, such as work or child care needs. Many of our students reflect a diverse community with often low-income and English as a second language as a barrier to academic success. Some students may have been unsuccessful in the traditional school setting and simply seek an alternative choice in curriculum programs. The school offers alternative choices through site-based learning, independent study, home study, and distance learning to enable students to acquire the knowledge necessary to make a difference in their lives.

The school provides a diverse, student-centered learning environment in which all students are held to high academic and behavioral standards. The school also emphasizes increased parental involvement, more one-on-one teacher and student interaction, student-driven participation in the learning process, technology access, varied learning environments, and choices in curriculum programs. Our personalized learning model is tailored to the needs and interests of each individual student. It is a combination of the best of home schooling and resource center-based classes. Personalized learning is dedicated to developing personalized learning programs for each student. Its intent is to engage each student in the learning process in the most productive and meaningful way to optimize each student's learning potential

and success. It allows the school to combine multiple assessment levels of student academic achievement through the regular recording of detailed learning records, compiling student work samples, and conducting annual state-mandated testing programs. The school offers this personalized learning option for students in grades TK through 12 with the ultimate objective of enabling pupils to become self-motivated, competent and lifelong learners. We are a year-round credit recovery program and we have 13 Learning Periods (LP) as our method of structuring the academic year.

The 2021-22 School Year was the first year VN accepted Title 1 funds. In 2022-23 VN will move to a Schoolwide Title 1 Program and the Title 1 funds will be reflected in this LCAP as a means of meeting the School Plan for Student Achievement requirements. The Title 1 funds will be used to supplement the strategic plan represented in this plan to help our at-risk students meet state standards and graduate.

## **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

The COVID-19 pandemic was an extremely taxing time for schools in California. Vista Norte Public Charter School students struggled with the same kinds of stressors that students in traditional schools experienced. Our attendance rates suffered for two years and we failed to meet our goals of 85% student attendance in the 2020-21 school year. We focused our 2021-22 school year on improving student attendance. We believe that the re-engagement strategies that we implemented to help students and families during the crisis also increased the student's average attendance rate by +8.52 points, up to 91.75%. Our teachers and retention support staff worked to address the serious concerns we had for students dropping out. Building relationships and staying connected to students decreased the dropout rate by 49.3%, to only 7.1%. Another important measure for us is our Success Rate, which is the percentage of students who graduate along with the percentage that is retained or return to their local school district. Our Success Rate increased +7.4 percentage points to 92.4% and our retention rate increased by +8.52 percentage points, up to 91.9%. Our dedicated staff and students successfully pulled together to remain engaged in the school program during the pandemic.

Graduation rates and credit completion rates increased over the last two years. With additional supports in place, such as tutoring, our students were able to earn on average 4.42 credits per Learning Period since the beginning of the school year. Our school has a large percentage of non-native English Language Learners who struggled compared to their peers, and earned credits at a 36.42% lower completion rate than the All Group. Students in the Low Income (higher by 0.09 credits) and Special Education (lower by 0.75 credits) groups had similar credit completion when compared to the All Group which reflects that instruction was varied for the needs of all students. Additionally, our graduation rate increased by +16.93. percentage points, up to 84.62%. Compared to our All graduation rate the English Language Learner graduation rate was 60.00% (-24.62% vs All), low-income rate was 82.05% (-2.57% vs All), and Special Education rate was 77.78% (-6.84% vs All). The foster youth group was fewer than 11 students which falls below the minimum sized student group for reporting purposes in this school year. Our decrease in student graduation rate is due largely in part to very small sample sizes at Vista Norte. Our graduating class was fewer than 50 students so the few students that failed to graduate on time significantly impacted our graduation rate. Our improvements in other academic areas (such as growth in our credit completion) show that we are implementing strong academic support across the student population.

We used a three year data set, from 2019-2022, starting with the CA Dashboard student group results and local data, in order to determine areas of success. Portions of the CA Dashboard were suspended during the 2019-20 and 2020-21 school years. The graduation rate for 2021 was 84.62%, which is an increase of +18.2 percentage points. Looking back at CA Dashboard results, we see that we experienced success on our Dashboard indicators prior to the pandemic, and in analyzing student group data, then and now, we realize that there are a few areas to highlight. Vista Norte Public Charter was authorized on July 1, 2018 and had an enrollment of only 392 students in 2018-19 school year. Our sample sizes were very small and due to the fact that 2019 school year was a baseline year the CA Dashboard lacks color bands. Our graduation rates were 84.6% in 2018-19, 67.69% in 2019-20, and 84.62% in 2020-21 school years. Our ELA, Math, and College/Career indicators also lacked color bands. We anticipate a significant increase in our CCI indicator as students have completed dual enrollment and CTE programs over the past three years. Many of those students are now nearing graduation and their results will be factored into the upcoming 2021-22 Dashboard. Our suspension remains low and will be reported this year at 0%. Our retention rate continues to be high, which is important, because we are credit recovery program.

We plan to increase our success by sustaining our system of continual improvement for student groups. We used student outcomes data from the latest DataQuest, CA Dashboard, CALPADs reports and local LCAP data tracking have clearly demonstrated that there are three main areas that must be addressed as goals and actions for the new 2022-2023 LCAP. One critical focus of our program is to improve the performance of our disengaged students. We identify, early on, which students are not completing their school work and then assign them tutors to ensure that they helped support student learning. We have utilized grant funding to expand our learning supports for student groups, including unduplicated students.

We also plan to sustain our success by implementing our school strategies and learning program to fidelity. The goals and actions articulated in our LCAP support our individualized learning model and adequate funding is provided to ensure that effective strategic supports such as tutors, student retention services and trauma-informed trained teachers continue. We monitor the progress of our students through multiple measures around engagement and academic performance. LCAP data and other local data are discussed quarterly and often shared with our educational partners, including the school board.

Our school survey data shows that 100% of our students felt safe at school this year. This is about an 11% increase from the previous year, and we are glad that students have reported they feel safe as the school has worked diligently to implement COVID-responsive safety practices across the school. Additionally, 98% felt connected to the school this year which was a massive increase from the 32% result in 2020-21 school year. This is very important to us because students' sense of safety impacts their learning and social-emotional well-being. Teachers reported that 100% feel safe and 100% feel connected to the school and their coworkers, which demonstrates that they have a meaningful buddy at work that supported them through the COVID-19 pandemic crisis. We have worked to ensure that there is a team spirit that connects everyone.

## **Reflections: Identified Need**

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

The CA Dashboard for 2020-21 and 2021-22 was suspended as a result of AB 98 and AB 130. However, results from 2019 and local metrics provided us a three year data set, which we used to inform our student group analysis. The first area of concern is that our CAASPP results show that English Learners, low-income and foster youth students are scoring below the "All Group" in English Language Arts and mathematics. Even though the unduplicated groups improved from the prior year, it was not enough to close the gap in performance. We saw similar achievement gaps during the pandemic, in key areas, such as ELA, mathematics, and credit completion, using the data we tracked for the Learning Continuity Plan. The 2021 CAASPP results for our English Language Learners was 5 percentage points below the All student group in mathematics and 41 points below in ELA. Our low income students were below the All group by 1 percentage point in math and 3 points in ELA. There were not enough foster youth students to report results on last year. Students with disabilities were 3 percentage points below the All group in mathematics and 27 points below in ELA. We plan to share student performance data with our educational partners and used their feedback along, with our analysis, to help develop LCAP goals with actions directed at these areas of identified need.

The next area of concern is that the reclassification rate was 2%, which is below the state average of 8.6%. Vista Norte Public Charter School is a K-12 school with a high proportion of non-native speakers, many of whom typically do not reclassify in K-4 grades. As we drill down on the data we will look for areas where we can increase student support for English Language acquisition. We plan to share this performance outcome with our educational partners and discuss how we might provide targeted assistance to our English Language Learners. With the success we have seen in our tutoring program with other student groups, we know they can help make a difference in the academic lives of our English Learners. We will need to have actions that address the specific requirements for re-designation like grades in ELD, NWEA scores, and performance on the ELPAC. An additional area of concern is to help students complete their core subject courses in ELA, ELD, and mathematics at a faster pace. Because we are a DASS independent study program, our students take courses in alignment with their academic plan. We can be strategic in when they start their course work and when they complete their course. We monitored their progress this year and are taking a careful look at the first semester data. Of those students who started their mathematics class in the first semester, 44.0% had finished by LP7. This percentage will likely increase to 65%, by the end of the year. We are likely to add this to the actions within our LCAP. English Language Arts courses were 14.29% done and the remaining will likely finish by June.

Closing the gaps in our graduation rate has been a challenge, and we are not yet satisfied with the outcome. in 2020-21, the All student group graduated at 84.62%, with our English Learner student group behind by 24.62 percentage points. Students in the low income group were just 2.57 percentage point below the All group. Our students with disabilities graduated at a 77.78% rate, which is 7 percentage points below the All student group. We plan to share this performance data with our educational partners and determine specific actions that will have a positive impact for our students.

Another area of concern is the All student group's NWEA Reading and Mathematics scores decreased from last year to this year (-63.43 Lexile points in Reading and -3.23 in RIT points in Mathematics) although there are areas of improvement in our unduplicated student groups. Our foster youth students realized tremendous growth in Reading (+255 points) and Mathematics (+12.47 RIT points). The NWEA Reading scores for our English Language Learners decreased by -133.24 Lexile points and -4.86 RIT points in Mathematics. We recognize

how important it is for our EL's to experience targeted support and interventions as they progress in their educational program. Low-income students scored about the same as the All students group although their scores were slightly lower versus the past year in Reading (-21.32 Lexile points) but only slightly decreased in Mathematics (-2.01 RIT points). However, our students with learning disabilities increased their scores this year (+23.15 Lexile points in Reading and +90.15 RIT points in Mathematics). We plan to engage families and students in their individualized academic learning plan and support systems like tutoring and counseling so that their educational performance is maximized at our school.

Our school survey data shows that 100% of our students felt connected this year. This is an important metric for us as it reflects the relationship that students and teachers cultivate by working together toward graduation. Face-to-face interaction with a caring adult will help students feel connected. It is very important to us to ensure that we are doing everything possible to provide students with time and attention to support them during their time with us. Teachers reported that 100% are feeling safe and 100% feel connected to the school. Results from our parent survey show that 77% of them feel encouraged to participate in their child's progress at the school. We strive to engage families in multiple and meaningful ways and we hope that increasing the two way communication will keep families connected to their school, and increase this data point next year.

The last point of concern is student attendance. Our expectation as a DASS independent study school is to have an attendance rate of 85% or higher each learning period. Our current attendance rate is 91.75%. While we are exceeding the goal, it is an ongoing focus as our students' progress is reliant on the submission of work each Learning Period. New actions were written into the new LCAP to address attendance and retention.

Due to the nature of our credit recovery, independent study, Dashboard Alternative Status School program, certain data points are not included in the LCAP. Students do not take Advanced Placement, or pass EAP in an amount greater than 11, and the CDE prohibits any potentially identifying student data. Chronic absenteeism is also not a match for our program, and not short-term independent study programs that have high mobility. Furthermore, our dropout rate is calculated as our non-completer rate, which includes any student who does not report to use that they have continued with another program, in order to complete their education.

The Local Control Accountability Plan (LCAP) provides funds for helping high needs students with social-emotional support, academic interventions, counseling and student engagement activities. Students have access to a robust tutoring program that supports their learning. Targeted academic interventions help close skill and knowledge gaps ensuring that students become competent graduates.

Our first goal is a focus goal directed at helping our unduplicated student improve their performance, especially our English Learners. Our second goal is a broad goal supporting student interest in a career tech or a higher education. The third goal is a maintenance of progress goal that meets the mission of our school program to retain students and help them graduate. The last LCAP goal is aimed at improving educational partner engagement, especially for our English Learners, low-income and foster youth students and their families.

# **Engaging Educational Partners**

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

This year Vista Norte Public Charter School (VN) received Title 1 funds and we are using the LCAP as our School Plan for Student Achievement (SPSA). We are adhering to federal guidelines for involving our educational partners in the needs assessment, parent compact, parent/family engagement policy and input into the direction of the federal program. We held our Title 1 Meeting on February 22, 2022, and shared student performance gaps and discussed how the federal funds could help by offering tutoring focused on literacy support. Throughout the year, we met to discuss student needs and how the funds could be appropriately directed to help improve student performance. Their input was incorporated into this LCAP.

The 2021-22 school year was the second consecutive year that Vista Norte Public Charter School experienced significant challenges related directly to the COVID-19 pandemic. However, to meet and adhere to the LCAP requirement for Parent Engagement, Vista Norte used various methods to solicit educational partners' input. We used traditional methods such as phone calls and flyers but also other means of communication such as text messages, online school messaging platforms (L4L Connect, Remind, TextNow, etc), and emails. Our educational partner groups included parents, teaching staff, support staff, administrators, students, school counselors, community partners, and others. We believe that many of the improvements in the school program are a result of how we elicited feedback from students, parents, guardians, teachers, administrators, and community partner groups. We also extended the window for feedback compared to prior years so that additional time was available for feedback. Input from our local SELPA was sought and shared with parents of students that have special needs. VN scheduled schoolwide meetings throughout the school year and presented the progress of our LCAP and grant funding to the participating members at those events. Some of the events include (but were not limited to) Back to School events, Open Houses, ELAC and PAC meetings, Student Award Nights, and Parent/Teacher conferences.

VN used every engagement opportunity to inform educational partners of the school's progress and about the school's LCAP goals. At every meeting school leadership shared state and local assessments including up-to-date summative and formative assessments highlighting progress in student achievement and areas of improvement. Substantial discussions occurred at several of these meetings over what might impact student learning and affect the graduation rate. School leaders also shared the actions that were implemented to achieve the school goals. In addition, parents were given information on graduation requirements and college/career readiness by school counselors. They also discussed CTE Pathways, dual enrollment, and past/current student events and opportunities. English Language Learner staff shared the importance of ELPAC testing and English Learner reclassification, and placement process along with the number and percentage of students being redesignated compared to Statewide averages. Site leaders discussed enrollment, retention, and shared changes to the school budget under local control; parents were also asked for consultation about the school LCAP goals and actions and services. Input from parents was documented and shared with school staff to get a better sense of the needs of students and parents.

The School Survey was given in February 2022 to all educational partners. These surveys were another means to gather input from individuals who were not able to provide feedback at one of our meetings and gather additional input.

From these meetings and surveys, VN was able to evaluate the concerns and needs of the community helping us to adjust our program,

increase student success, and increase parent communication. Listed below are the details of the process: Comprehensive Needs Assessment meetings' target audience included district administrators and site administrators. Administrators reviewed data aligned with the metrics to determine if progress was being made in achieving desired outcomes. Various meetings were scheduled as data became available locally and through the state (e.g. Dashboard data). Data analysis included a broad overview of reviewing aggregate data to determine areas of progress and/or concern. Follow-up meetings included a deeper dive into the data by reviewing student detailed reports.

This school year, VN held regular English Learner Advisory Committee (ELAC) meetings. Meetings were held on the following dates: 9-13-2021: Advisement of ELAC's purpose, Review of Responsibilities, Elections, Review of Mission/Vision/Student Learner Outcomes, LCAP and Title 1 review, Review of ELO Grant funding, Tentative Scheduling of Upcoming Meeting

11-17-2021: Purpose of ELAC, SGI class offerings, School Counselor introduction, Dual Enrollment process and course offerings, NWEA and ELPAC testing, Raffle winners

11-19-2021: Election results, Training of Officers, Review of bylaws, LCAP review and comment, Title 1 and English Learners 2-9-2022: Review of Title 1, Review of Family and School Compact and Parent Engagement Policies, Reclassification update for school sites, State testing update, COVID safety update

5-11-2022: Introduction of new ELL paraprofessionals, Graduation 2022 update, SGI class offerings, Annual State Assessment update, COVID safety update

5-18-2022: LCAP draft overview for parent and student input, Final State Assessment update for the year, Graduation update with dates and locations, Anticipated meeting schedules for 2022-23 school year

This school year, VN held regular Parent Advisory Committee (PAC) meetings. Meetings were held on the following dates:

5-18-2022: Review of LCAP draft overview for parent and student input, Graduation Update, Summer School update, SGI course offerings, Important Calendar Dates, Requests for field trips and important school events for next school year

Certificated, Classified Staff and Administration met for professional development throughout the school year. Agendas for the meetings varied by School Principal but topics included: LCAP goal updates, LCAP budget updates, Needs Assessments, Statewide Test requirements and participation percentages, Social-Emotional and Trauma-Informed best practices, strategies for support of unduplicated student groups such as foster youth/low income/special needs/students with disabilities, and curriculum updates. The meetings included a number of different feedback opportunities through multiple collaborative activities (gallery walks, polls and surveys, small- and large-group conversations, and others).

In May, a draft of the LCAP was posted on the Vista Norte Public Charter School website for two weeks and made available for public comment. The public was provided the opportunity to call or email the principal and provide their input during this time. No input was

#### received.

Our school board met in May and reviewed the LCAP data and discussed the actions of the LCAP. They support the development of the LCAP and our goals. We had our public hearing on June 7, 2022, and our school board approved the Local Control and Accountability Plan on the same day. Board approved the Local Indicators at the same meeting as the LCAP. The Board adopted the budget at the same meeting of the LCAP Adoption.

#### SPECIAL EDUCATION SELPA SUPPORT:

We have a good partnership with our SELPA administration and the following collaborative activities have had a positive impact:

- The El Dorado Charter SELPA participates and provides guidance in the CDE's Special Education Monitoring Processes
- The El Dorado Charter SELPA provides program and technical support by the Program Specialist and/or other SELPA team members
- Dropout (and Graduation) data for special education students are reviewed in a collaborative process with the El Dorado Charter SELPA.
- Staff training related to special education students is provided by the El Dorado Charter SELPA as needed and requested.

#### A summary of the feedback provided by specific educational partners.

The following aspects of the LCAP will be continued because of educational partners' support via verbal and written feedback:

- All goals and actions will be continued and monitored. Educational partners were supportive of maintaining the broad goals that
  captured specific actions intended to provide services to all students and actions intended to provide services to English Learners,
  foster youth, low-income students, and students with exceptional needs.
- There will be a continued focus on Goal #1: Increase Academic Performance.
- Parents would like to see an increase in dual enrollment course offerings and CTE pathways.
- We will allocate more resources to address SEL components to gain college and career readiness.
- Increased SEL support and strategies for motivation and encouraging students to complete credits so they will graduate.

We will continue to collaborate with educational partners throughout the school year to explore and monitor the progress of implemented actions.

#### A description of the aspects of the LCAP that were influenced by specific input from educational partners.

As a result of sharing our school's LCAP Data Report with educational partners and based on their input, Vista Norte Public Charter School will implement the following goals and direct funds accordingly within our plan. Specifically, parents from our PAC/ELAC group expressed how important it was for their student(s) to have access to the workplace. As a result, funds were increased for Goal 2 (Students will gain skills for college or career-readiness) and Goal 3 (Increase Student Retention). Both goals directly correlate to the needs and concerns raised by educational partner. Teachers and staff expressed how important attendance and retention were for the students, so funds were increased in Goal 3. Students, parents, and staff all communicated the importance of students gaining and demonstrating college and/or

career skills as evidenced by engagement in college-level dual enrollment courses, participation in CTE coursework, and the ability to navigate various technologies and platforms. In addition, parents, and staff all communicated the need to eliminate barriers to students' retention in our program. Transportation funds were increased in Goal 3 Action 3 in order to improve attendance. Funding decisions directly correlate to the needs and concerns raised by educational partners, including school leadership, in accordance with the school's mission.

We added an additional action to Goal 1.7, Goal 3.5, and Goal 4.4 to support the learning needs of students in our Title 1 program. With consultation from educational partners, federal funds were directed toward tutoring and academic supports in order to improve students' performance on the CAASPP. We shared that our low-income students were underperforming in Mathematics and English Language Arts.

Students specifically asked for increased resources to meet social-emotional needs, additional 1:1 extended academic support, and transportation needs. An increase in funding was added to Goal 1 Action 2 for tutoring, and Goal 1 Action 4 for social-emotional support from counselors and other service providers. Transportation was increased in Goal 3 Action 3, in order to increase English Learner, low income and foster youth students' attendance.

## Goal

Goal #	Description
1	Increase Academic Progress: This is a focus goal for increasing academic progress for all students, especially our English Language Learners, low-income and foster youth, who struggled during the previous year. In the next three years, we will have mitigated the negative impact learning loss had on our students, and we will see improvement in our NWEA, EL reclassification, credit completion and graduation rates.

#### An explanation of why the LEA has developed this goal.

As a result of our analysis on key state and local data, we determined the need for a focus goal on academic performance for all of our unduplicated students. This new goal specifically addresses low key metrics such as the English Learner reclassification rate, credit completion, and graduation for our student groups. We looked at our student group data, which reveal performance gaps between the "All" Student Group, and the unduplicated students. Our students also take the NWEA MAP assessment, and we measure academic growth from year to year in this way. This year, performance gaps among student groups were also revealed, using that assessment. We understand the gaps that need to be closed for our students, and this focus goal was carefully designed to support their academic needs with targeted interventions and tutoring.

We sought the consultation of our educational partners, and involved them the LCAP process, which we believe promotes positive engagement, buy-in and trust. We know that additional tutoring, interventions, and counseling support will help address the learning loss over the next few years.

## Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Overall, we were able to implement the main components of the actions in Goal 1. Academic interventions were made for students, including expansions of tutoring supports and flexible hours for instruction. Our teachers, tutors, and paraprofessionals provided on-site and virtual support via Google Classroom and Google Meets to help support credit completion and content mastery. We saw an increase in the All group credit completion over prior year with our low income/socioeconomically disadvantaged group performing slightly above (0.09 credits per Learning Period) the All student average. Student performance on local testing showed mixed improvements amongst slight decreases with an increase in Students with Disabilities' Mathematics score of 4.02 RIT points score over prior year. Foster Youth outpaced the growth of the All student group by +14.72 points and Low Income/Socioeconomically Disadvantaged students were slightly lower (-1.41 points) than the All group. Our Reading NWEA scores dipped slightly this past year by -63.43 points. A bright spot in the Reading NWEA testing average scores was again Foster Youth with an average +172.73 points higher than the All group, Low Income/Socioeconomically Disadvantaged were -25.74 points lower than the All Group, and English Learners (-404.38 points lower) and Students with Disabilities (+31.33 points higher).

Our school has a target of 100% fully credentialed teachers. This year, we maintained a 100% fully credentialed staff. School leadership is dedicated to providing professional development to both new and experienced staff members through grant funding that supports social-emotional awareness, trauma-informed education, and professional best practices.

Although we implemented most of Action 5 (Student activities that increase learning efforts such as awards, celebrations, field trips, and enrichment), we were unable to provide the field trips for students. During pre-pandemic years the school was able to send many students on field trips and enrichment learning opportunities outside of the school campus but COVID-19 safety protocols mitigated this due to strict social distancing rules. We were able to continue student awards and celebrations through a shift to virtual options. As the school shifts back to a traditional environment we anticipate a return to off-campus field trips and enrichment opportunities.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services; because actual expenditures were approximately the same as budgeted expenditures and were principally directed towards our English Language Learners, low income and foster youth students. We were able to meet our budgeted expenditures as shown in the 2021-2022 Contributing Actions Annual Update table for estimated actual expenditures.

An explanation of how effective the specific actions were in making progress toward the goal.

Our overall analysis of the seven key actions in this goal are that we have continued to improve academic progress and outcomes for our students this past year. Credit completion and Mathematics NWEA testing reflect an increase in student academic proficiency and our graduation rate of 84.62% reflects that students continue to progress toward their diplomas. Our reclassification rate increased from 2.8% to 2% and while it is still below the State average, is statistically similar. The decrease can be attributed to very low sample sizes as even one student impacts the percentages measurably. The academic interventions completed by tutors and paraprofessionals made a measurable positive impact in student performance this past year. Two student groups that we plan to target support for in the next year are Students with Disabilities and English Learners. We anticipate that LCFF and Title 1 funding will allow us to increase services for our English Learners and at-risk student populations as we implement school-wide programs next year.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

There were three changes made to the metrics reported in this goal. First, we were reporting RIT scores for NWEA Reading results, and now we are reporting Lexile scores, because that aligns with how scores are reported at a national level. We did this in order to be more comparable with other schools using Lexile reading scores. Secondly, there was no calculation for the English Learner Performance Indicator, so we reported ELPAC Levels 1-4, in order to show that we are examining the data that is available for our English Learners. We will report the ELPI when it becomes available on the CA Dashboard. This year we are using the LCAP to meet the federal requirements for the SPSA. An additional action was included to describe the Title 1 program and uses of those funds under this goal.

## Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We were able to implement the actions in our career and college readiness, with a comparable amount students completing our Professional Skills this year (101) than last year (115). Students were assigned and supported in their completion of standards-based coursework at the school with supplemental learning activities for our English Learners, low-income/socioeconomically disadvantaged, and foster youth students. The school made substantial purchases of technology to support students' connectivity (laptops, wireless Internet hotspots, and extra chargers) as our distance learning was still an ongoing focus during the school year. Professional development was scaled back this year due although we did provide remote opportunities as much as possible. An example of a remote professional development opportunity was "all staff" meetings where Principals and their leadership teams would meet with teachers and classified staff to discuss school priorities, update the staff on changes in COVID-19 pandemic guidance, and credit completion/attendance of students.

Our CTE program was challenged during the pandemic due to the fact that career technical education courses typically are more hands-on and require students to be present for courses. When possible, we offered smaller class sizes with social distancing measures but the smaller class sizes affected the number of students that completed pathways. In 2021-22 school year, 14 students completed a CTE pathway. We anticipate a return to regular classroom instruction which will improve our CTE student completion numbers in 2022-23 school year. The number of students that completed a pathway when attempted was 100% (versus 57.14% last year) which does represent that intensive support was able to be implemented as class sizes decreased.

Our actual expenditures in Action 2.2 reflect a decrease in professional development. We attempted to continue our professional development throughout the pandemic but the shift to a remote/distant model lowered our actual costs. Remote professional development is cheaper due to fewer costs incurred in the event itself but we did attempt to maintain a positive staff culture as much as possible. We believe that while our expenditures decreased this past year, our annual staff survey reported an increase in staff satisfaction; 93.96% believe that support for professional learning and growth is available, and 90.87% feel that professional development activities have been valuable.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were material differences that occurred as a result of not being able to implement professional development. However, this did not impact the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services, because other strategies; such as purchasing technology for students (Action 2.3), within the action were increased, and which were principally directed towards our English Language Learners, low income and foster youth students.

An explanation of how effective the specific actions were in making progress toward the goal.

We effectively implemented our College and Career-Readiness goal, as measured by key metrics, such as participation in CTE and Professional Skills courses, a standards-based curriculum, and the California Assessment for Student Performance and Progress. Our English Learners, low-income, and foster youth students were able to engage

in activities that focused on career-readiness and/or college readiness. Professional skills courses had an enrollment of 101 this year (a slight decrease of 15% versus prior year). 100% of our students had access to a broad range of courses. The results from last year's CAASPP test were 24% in ELA and 13% in Math which should improve as we return to a traditional school environment with our one-on-one academic support from teachers and tutors. We were able to implement our college and career-ready, standards-based instructional program this year. Additionally, we ensured that students had access to technology and a high level of connectivity in order to support their learning efforts.

New this year is the required metric for measuring the percentage of seniors completing the A-G courses and a CTE pathway. This is a challenging combination of specific course completion for very high-performing students. Last year 0% of our seniors were able to be counted in this metric. We are using the most current data from the CDE's DataQuest.

## Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

While we nearly met our goal of 92.4% student success, the school did see an increase. Our student retention rate increased to 86.5% and we continued to service all students (including our unduplicated English Learners, low-income, and foster youth) with multiple Student Retention Support personnel whose primary role is to communicate, support, and encourage struggling students to continue working on credits. This local data is currently not disaggregated, and we are hoping to improve our capacity to report by subgroups. Our attendance rate reflects this increase in support, as our attendance rate increased to 91.75%.

The pandemic forced us to work harder and more creatively to re-engage students who were struggling. Some of our shifts included directing funds toward student support, whether it was contacting students with local resources, holding social-emotional conversations with our counseling team, or sometimes just spending time on the phone talking. We did not expend all of our funds for nutrition this year and the greatest reason for this was the lack of students on-site regularly. We plan to increase our food offerings as the school returns to a traditional model in the 2022-23 school year. If necessary, we will adjust our budget to accommodate a need that is greater than anticipated. Our low-income students did continue to access food/nutrition and transportation services if they needed them.

Although we implemented most of Action 3.2, many of the services we previously offered were unable to be executed. Examples of services we had budgeted for but could not offer to students was Paws2Share (a program where dogs are brought to the resource centers to spend time with students for social-emotional support), and on-site yoga classes. We offered virtual yoga via YouTube live stream and a number of students did participate but those classes were held at no cost to the school. In the 2022-23 school year we anticipate a return to these school offerings, an increase in student transportation, and other supportive services.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were material differences that occurred as a result of not being able to implement transportation and meals as anticipated. Also, some social-emotional support was not fully implemented and we were not able to adequately backfill positions. However, this did not impact the Planned Percentages of Improved Services and Estimated Actual

Percentages of Improved Services, because other strategies, such as student retention supports, within the action were increased, and which were principally directed towards our English Language Learners, low income and foster youth students.

An explanation of how effective the specific actions were in making progress toward the goal.

Overall, while we decreased the retention of our students, other important metrics showed strong data such as the success rate, attendance rate and continued low drop-out rate. As shown above, in the Measuring and Reporting Results chart, the success rate has stayed above the 80% mark, to 92.4% in 2022. This is the result of a comprehensive and strategic approach to helping students remain engaged in their education and help them overcome barriers to learning. Our retention rate currently is 86.5% this year but attendance increase (91.75%) and student success also met our goal. The retention rate reflects a very small sample size due to the low student enrollment at the school and even a few students will significantly impact that data point. The dropout rate this year is 18.75%, which is a slight increase from last year but again due to a small sample size that will impact this data point greatly. These metrics show that we have improved attendance and student outcomes and that the actions are effective in this goal even though we did have a slight increase in our dropout rate.

We expect that these actions will sustain student's sense of connection for our English Learners, low income and foster youth student groups. ## Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We were able to implement the actions in Goal #4, Increase Educational Partner Engagement. There were over 490 partcipants in school activities and events this year. This was a challenge for us last year, but as a result of adapting additional methods of connecting and engaging our partners, we were able to sustain and improve on some of our actions. Parent conferences, orientations and school events were in-person this year and we continued to utilize the virtual meetings platforms to engage parents that way if they desired that option. PAC/ELAC meetings were also held this year and so far we have had 65 participants.

Goal 4 in VN LCAP is to Increase Educational Partner Engagement. School leadership partnered with our Charter Affairs team to support two outreach groups, one to support our LatinX students an parents (Latino Initiative for Growth and Advocacy - LIGA) and one to support our African American students and parents (Black Parent Aliiance - BLA). The meetings are structured to be inclusive of all races and genders and help all participants increase their capacity for inclusion and embracement of diversity amongst our student population and greater society. Events were held on the following dates:

10-4-2021 and 10-11-2021: LIGA's Hispanic-Latino Heritage Month virtual celebration honoring and commemorating achievements of the Latinx community. Students and staff benefited from an aray of motivational guest speakers, history and culture.

2-1-2022, 2-8-2022, 2-15-2022, 2-22-2022, 2-28-22: BLA's Black History Month virtual summit is meant to inspire staff and students with culturally specific events created by Black professionals representing educators and the community. Inclusivity and acceptance of diversity is the goal.

5-5-2022: LIGA's Cinco de Mayo event where staff and students engaged in the history and true meaning of Mexico's Cinco de Mayo celebration. Inclusivity and acceptance of diversity is the goal.

This school year, VN intended to hold regular student events but social distancing rules significantly limited the number of events that were successfully held. Student participation in the events was lower than in prior years, although we do expect increased numbers of events and student participation as the school returns to a traditional on-site model. Examples of some of our school events for students and the dates the event were held are:

We are continually trying to improve how we can engage the most amount of parents and give them input into the school. We increased our participation on our school survey, which helped provide insight into our LCAP goals and other school processes. Of the parents responding to the survey, 77% feel encouraged to participate.

We implemented most of Action 4.1, Community/Parent Liaison goal and while we were not able to provide as many of the activities as we have in the past our Community Liaisons did host virtual webinars and student information sessions with community partners and the support of the school counselors. We adapted by providing other engaging and meaningful engagement activities such as virtual job fairs, career interest sessions, and WIOA support. This is an important goal for us and our educational partners would like to keep this goal moving forward.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services; because actual expenditures were approximately the same as budgeted expenditures and were principally directed towards our English Language Learners, low income and foster youth students. We were able to meet our budgeted expenditures as shown in the 2021-2022 Contributing Actions Annual Update table for estimated actual expenditures.

An explanation of how effective the specific actions were in making progress toward the goal.

Overall, we were successful with this goal, as measure by the school survey and participation results. We saw an increase in parents feeling encouraged to participate, rising to 77% this year. We believe that our positive engagement efforts resulted in 100% of the students reporting that they feel safe this year and 100% of the teachers reporting that they feel connected with a partner at work. Participation in conferences and ELAC meetings slightly increased but our PAC numbers increased significantly. We anticipate higher PAC participation as our school transitions to schoolwide Title 1 support.

The LCAP development process serves three distinct, but related functions:
