

Budget Overview for the 2023-24 School Year Projected Revenue by Fund Source



Of the \$8,993,439.00 in LCFF Funds, \$2,462,564.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

In 2023-24, Vista Norte Public Charter is projecting it will receive \$2,462,564.00 based on the enrollment of foster youth, English learner, and low-income students. The Local Control Accountability Plan (LCAP) directs the Supplemental and Concentration funding into goals and actions designed to help high needs students with social-emotional support, academic interventions, counseling and student engagement activities. Students have access to a robust tutoring program that supports their learning. Targeted academic interventions help close skill and knowledge gaps ensuring that students become competent graduates. A brief description of the LCAP is that our first goal is a focus goal and the first action is directed at helping our English Learners. Our second goal is a broad goal supporting student interest in a career or a higher education. The third goal is a maintenance of progress goal that meets the mission of our school program, which is to retain students and help them graduate. The last LCAP goal is aimed at improving our educational partner engagement, especially for our English learners, low income and foster youth:



The text description of the above chart is as follows: In 2022-23, Vista Norte Public Charter's LCAP budgeted \$2,017,207.00 for planned actions to increase or improve services for high needs students. Vista Norte Public Charter actually spent \$2,674,763.00 for actions to increase or improve services for high needs students in 2022-23.

The difference between the budgeted and actual expenditures of \$657,556 had the following impact on Vista Norte Public Charter's ability to increase or improve services for high needs students:

Students in our independent study program were able to benefit from fully funded intervention programs like tutoring. Additionally, English learners, foster youth and special education students were able to receive socioemotional support with counseling services and trained staff. Our student retention staff were fully funded and able to help provide interventions and outreach to support our students' regular attendance.

Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Vista Norte Public Charter (VN or VNPC) is a Dashboard Alternative School Status (DASS) school, with Transitional Kindergarten (TK) through Grade 12. TK through 12th grade falls within the independent study personalized learning model. VNPC has resource centers located in San Bernardino and Riverside counties. We currently serve a population of 638 students in primarily urban and suburban areas, although some students in San Bernardino County reside in more rural areas. Our charter school's personalized model is conducted primarily through one-on-one interaction with a teacher and student. We offer additional opportunities for academic support, such as Small Group Instruction (SGI), literacy support, English Language learner support, and tutoring.

We are a charter school that serves a diverse student community with the mission of engaging students in learning, who are no longer enrolled in a traditional classroom program, or who prefer a personalized learning education in an alternative setting. Our goal is to successfully prepare students for work or college readiness through our integrated and personalized program of job readiness coursework and standards-based curriculum. Some students need the flexibility of an independent study model to meet family obligations, such as work or childcare needs. Many of our students reflect a diverse community with often low-income and English as a second language as a barrier to academic success. Some students may have been unsuccessful in the traditional school setting and simply seek an alternative choice in curriculum programs. The school offers alternative choices through site-based learning, independent study, home study, and distance learning to enable students to acquire the knowledge necessary to make a difference in their lives. The school provides a diverse, student-centered learning environment in which all students are held to high academic and behavioral standards. The school also emphasizes increased parental involvement, more one-on-one teacher and student interaction, student-driven participation in the learning process, wide availability of home-based and school-based technology access, varied learning environments, and choices in curriculum programs. Our personalized learning model is tailored to the needs and interests of each individual student. It is a combination of the best of homeschooling and resource center-based classes with a supportive and facilitative staff that believe all students have the capacity to learn and graduate from high school.

We believe that personalized learning is a central focus of how we are able to support our student population. Our personalized learning programs provide a unique experience for each student. The intent is to engage each student in the learning process in the most productive and meaningful way to optimize each student's learning potential and success. It allows the school to combine multiple assessment levels of student academic achievement through the regular recording of detailed learning records, compiling student work samples, and conducting annual state-mandated testing programs. The school offers this personalized learning option for students in grades TK through 12 with the ultimate objective of enabling pupils to become self-motivated, competent, and lifelong learners. We are a year-round credit recovery program and we have 13 Learning Periods (LP) as our method of structuring the academic year.

We have worked to expand our CTE and college dual enrollment programs in support of our LCAP goals. Students are provided with multiple college options through articulated agreements with local community colleges and they receive both high school and college credits on their academic transcripts upon course completion. The options provided to students were based upon a student needs assessment that included student feedback and transcript analysis. We also paired some of the course options with current and upcoming CTE pathways that are/will be offered by the school so as to maximize the amount of relevant credits for students to receive. Our goal is to continue expanding dual enrollment options to increase student proficiency in the completion of college-level work, blur the line between secondary and post-secondary continuation, and accustom students to the concept of learning as a lifetime endeavor.

The 2021-22 School Year was the first year Vista Norte accepted Title 1 funds. In 2022-23, Vista Norte became a Schoolwide Title 1 Program. The use of the Title 1 funds are described in this LCAP, in order to meet the School Plan for Student Achievement (SPSA) requirements. The Title 1 funds may be used to supplement the strategic plan directed at helping our at-risk students meet state standards and graduate. We are using the LCAP to fulfill the planning requirements for Comprehensive Support and Improvement (CSI).

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

We analyzed our school data from the CA Dashboard, DataQuest, our SARC, and our LCAP Annual Data Report, which aligns with the 8 state priorities. WASC data was also reviewed. Although the school is identified for Comprehensive Support and Improvement (CSI), due to the federal graduation rate, there were significant successes as shared in the following key metrics below.

Graduation Rate

Our Dashboard Alternative Status Schools Graduation rate was calculated by the CDE at 82.7%. This is decrease in 5% points from the previous year. English learners graduated at 83% and students with disabilities graduated at 92%. The Hispanic student group graduated at 82%. Our socioeconomically disadvantaged students graduated at 82% last year. We plan to increase our success with our students by increasing, supports such as tutoring, for all seniors.

Success Rate

Another important measure for us is our success rate, which is the percentage of students who graduate along with the percentage that are retained or return to their local school district. Our success rate this year is 92.6% and is up 0.4 percentage points. This is the highest it's been in three years and shows that our mission of meeting students' academic and social-emotional needs continues to be effective.

Retention Rate

One critical focus of our program is to improve the performance of our disengaged students and address social-emotional concerns such as trauma. We identify, early on, which students are not completing their schoolwork and then assign them tutors to ensure that they helped support student learning. On average, our retention rate improved by +6.5 percentage points to 89.9%. This is due to the collaborative teamwork between our teachers, tutors and counselors.

Attendance

Our attendance rate is high at 90.68% and is about the same as last year. We believe that the reengagement strategies that we implemented, to help students and families during the crisis, also contributed to increasing the student's average attendance rate. Our teachers and retention support staff worked to address the serious concerns we had for students dropping out. Building relationships and staying connected to students keep the non-completer low at 7.3%. This is about the same as last year. This means we continue to keep students enrolled in school and attending regularly.

Suspension Rate

Suspension rate was rated "Very Low" on the CA Dashboard. It was 0%, which was an improvement from 0.0% the previous year. Homeless students were in the very low range, and Hispanic, along with socioeconomically disadvantaged students also had 0% suspensions. There were no expulsions.

School Survey Results

Our school survey data shows that 97% of our students felt connected this year. This is an important metric to us and we expect to be higher. Face to face interaction with a caring adult will help students feel connected. 100% of the students surveyed said that they feel safe at school. It is very important to us to ensure that we are doing everything possible to provide students with time and attention to support them during their time with us. Teachers reported that 100% are feeling safe and 97% feel connected to the school. We have high expectations for school safety and connected and we intend to continue to improve on our school connectedness.

How will we maintain our success?

We plan to maintain and build on our success by implementing our LCAP actions to fidelity, carefully monitor our progress and discuss our results within our professional learning community. We will continue to grow in our capacity as we engage in a process of continual improvement, based on the Plan-Do-Study-Act model. Data discussions with teachers and administration will be grounded in learning community protocols aimed at improving performance on student outcomes.

The goals and actions articulated in our LCAP support our individualized learning model and adequate funding is provided to ensure that effective strategic supports such as tutors, student retention services and trauma informed trained teachers continue. We monitor the progress of our students through multiple measures around engagement and academic performance. LCAP data and other local data are discussed quarterly and shared with our educational partners, including the school board.

Due to the nature of our credit recovery, independent study, Dashboard Alternative School Status program, certain data points are not included in the LCAP. Students do not take Advanced Placement, or pass EAP in any amount greater than 11, and the CDE prohibits any potentially identifying student data. The federal calculation for the 4-5 year cohort graduation rate and the chronic absenteeism rate are also not a match for our program, because the calculations are for seat-based programs, and not short term independent study programs that have students with high mobility. We utilize alternative metrics such as the one-year DASS graduation rate and local attendance rates to monitor and report our students' progress towards graduation. Furthermore, our dropout rate is calculated as our non-completer rate, which tracks any student who does not report to us that they have continued with another program to complete their education.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

Our school was identified for Comprehensive Support and Improvement (CSI), as the result of a low federal 4-5 year cohort graduation rate. This section describes our needs assessment, in order to meet the federal requirement for CSI. We used State and local metrics to identify student groups' performance gaps and resource inequities. We used student outcomes data from the latest CA Dashboard, DataQuest, CALPADS reports and local LCAP data tracking. The data shows that there are multiple areas that must be addressed as goals and actions in the LCAP. Our internal data collection and reporting system uses metrics that are aligned with state indicators and local performance indicators. We regularly monitor and evaluate our identified outcomes, so that we can make program adjustments in areas that require improvement. As a professional network, we used a fishbone protocol for our needs assessment around our low graduation results. This revealed that there are multiple causes that play into the graduation rate that need to be managed, such as, credit completion, attendance, student motivation, parent engagement and tutoring. The school data demonstrates that we will need to improve in the areas of graduation (5-year cohort), EL reclassification, academic indicators by increasing tutoring supports for students who are inline to graduate.

State performance indicators from the California School Dashboard show the following indicators were low or very low:

5-Year Cohort Graduation Rate

The federal 4-5 year cohort graduation rate was very low and qualified us for CSI. The 5-year graduation rate was 23.3% in 2022. This is far below the 68% threshold. The student group data used in our analysis is from the 2022 Dashboard and is reported in DataQuest. The lowest performing student groups were our English learners at 7.7% and homeless students at 13.2%. Hispanic students graduated at 18.9%. These groups were 5-16 points below the All student group. Our students with socioeconomically disadvantaged students were at 22.5%, and the African American group graduated at 23.5%. Students with disabilities graduated at 27.3% and was the highest. All other groups were between 4-20 points below the All Student group. We recognize the inequities between the highest student group and the other student groups. Our plan to address the gap in graduation scores is outlined in our CSI plan in the LCAP.

CA Dashboard English Language Arts

Our Academic Indicator for English Language Arts showed all at 68.9 points below standard and received a low status. Our socioeconomically disadvantage student group scored at 76.4 points below standard, our English learners were at 118.2 points and students with disabilities had 120.5 points. Student group was at 36 points. These three groups were rated very low. Hispanic student group had a low status at 66.2 points. These groups were about 2-52 points below the All group. African American, White, Asian, homeless, foster youth and other student groups did not have enough students for a valid calculation. However, we know they are low because of their NWEA diagnostic scores. This is because we serve students who are traditionally 3-4 grade levels behind in their schooling. Most of our students come to us deficient in credits and skills and they score at the 7th grade level in ELA.

CA Dashboard Mathematics

The Academic Indicator for Mathematics for the All student group was 152.7 points below standard and received a very low status. Our socioeconomically disadvantaged students scored at 157 and our Hispanic students scored at 152.9 which was rated very low. Also very low were our English learners at 175.7 and our students with disabilities at 193.4 points. African American, White, Asian, homeless, foster youth, and other student groups were the did not have enough students for a valid calculation. We know from their NWEA diagnostic that they are low as well. This is because students who enroll with us who are typically 3-4 grade levels behind in their schooling.

There were no student groups who were two or more performance levels below the "all student" group. In most cases, the performance levels among all of the groups were the same for the graduation, ELA, and mathematics indicators.

English Learner Performance Index

The English learner Performance Index shows 25.7% making progress, based on their ELPAC scores. This is very low growth. We are working towards moderate growth. The English Learner reclassification rate stayed the same as the previous year and is at 2% this year. This not what we expected. We expect to be above the CA average of 8.6%. However, the English learner progress is important to us and we made it Goal 1 Action 1.

Credit Completion

Our credit completion rate was 53% below where it was last year at this same time. With additional supports in place, such as tutoring, our students will be able to earn on average more credits. Students in the socioeconomically disadvantaged group and students with disabilities were about the same credit completion compared to the All group.

Our first goal has the highest priority and is a focus goal, with actions directed at helping our unduplicated student improve their performance, especially our English learners. They are a priority because their group traditionally tends to be one of the lowest performing. The first LCAP Goal 1 Action 3 includes intensive tutoring designed to support our CSI plan. We expect to see our graduation rate improve. Our second goal is a broad goal supporting student interest in a career tech or a higher education. We expect to see our ELA and math indicators improve by 1 level. The third goal is a maintenance of progress goal that meets the mission of our school program to retain students and help them graduate. We expect that our success rate is above 80%. The last LCAP goal is aimed at improving educational partners engagement, especially for our unduplicated students and their families. We hope to increase our survey results over time.

Support for Identified Schools

We are a single-school LEA with Dashboard Alternative School Status. This is a summary of how we supported ourselves in the development of the Comprehensive Support and Improvement plan. With guidance and training from the CDE, the county, and our local professional network, we did the following:

• We assigned our State and Federal Programs coordinator to provide leadership for the school in conducting a needs assessment. By analyzing the 5-year cohort graduation data to identity gaps and inequities between the highest student group and the other groups. The results are described in the Identified Needs section in the LCAP Plan Summary. Our framework was Carnegie's Improvement Science and our model is the Plan-Do-Study-Act process for continual improvement.

• The type of data collected for the needs assessment was CA Dashboard, math, ELA, and graduation results, attendance data, tutoring participation data, and credit completion data.

• The data informed the CSI plan by guiding the root cause analysis towards intensive tutoring, as a viable research-based strategy that would increase student math skills credit completion and therefore graduation rates. The data revealed that students who participated in tutoring had 50% more credits completed than those who did not. As a result, Goal 1 Action 3 in the LCAP provides for intensive tutoring.

• The educational partners were engaged in the process through meetings held by leadership sharing the data and eliciting consultation from ELAC, PAC, staff and student groups. Our discussions centered on equity for all students with regards to learning expectations, obstacles to achieving their potential, and access to quality materials and instructional support such as tutoring. Additionally, as a professional network of DASS independent study schools, we reviewed graduation data using the fishbone protocol. This helped to reveal root causes. A deeper dive was done with the fishbone protocol with our admin team around credit completion rates and the potential resource inequities questions helped frame our analysis. We then engaged our educational partners, PAC/ELAC parents, students, teachers, classified and administration,

in the analysis of the data. This led to their support for Goal 1 Action 3, which is assigning intensive tutoring for students as the means to improve the graduation rate.

Evidence-Based Intervention - Intensive Tutoring

The State and Federal Programs coordinator supported the school by leading the principal's team through the needs assessment, identifying the evidence-based strategies, and they then led the staff through the selection of evidence-based strategies at their staff meeting.

The process for matching the selected intervention with the identified need was a collaborative endeavor through our professional network. We met regularly to study the data. From our needs assessment, we saw that those who attended tutoring earned 50% more credits, and we came to believe that tutoring could potentially close credit completion gaps. We then investigated other best practices for improving graduation.

With guidance from CDE and county offices, we searched out solutions to improving our graduation rate and we were guided to the following evidence-based research. This research on math tutoring, using a randomized controlled trial, with 2,718 males in the ninth and tenth grades, from the south and west sides of Chicago. They were 90% on free and reduced lunch programs and 95% were either African American or Hispanic. They demonstrated an increase in math scores by 0.19 to 0.31 standard deviations, as well as increases in math grades by 0.50 standard deviations. The positive impact of tutoring is also supported from the meta-analysis of the studies listed above, with one study in particular stating that there was an effect size for this practice above a 0.33 standard deviation (Nickow, Oreopoulos, Quan, 2020).

The rationale for selecting the intervention is based on three main components. First of all, our students are very low in math skills, which inhibits their capacity to earn credits towards graduation. Secondly, education research points to intensive tutoring as a viable means to increase math performance, which in turn will increase credit completion. Thirdly, increasing students' capacity to earn credits through intensive tutoring will yield higher graduation rates.

Therefore, our professional network team and our educational partners selected the following research-based strategies to implement:

- * We will provide one-on-one intensive tutoring.
- * We will provide positive social incentives for good attendance.
- * We will track specific data for our seniors through site teams of teachers, counselors, and student retention support staff.
- * We are going to continue seeking educational partner involvement and input.

We will address the low performance in the areas of graduation, ELA, and mathematics, by assigning intensive tutoring to students who demonstrate low scores as determined by their NWEA diagnostic results. These low scores reveal that there are inequities that must be resolved through the implementation of our plan.

Resource Inequities Analysis

The State and Federal Program coordinator provided guidance to the school through a resource inequities analysis. This showed that more funds should be added to LCAP Action 1 Goal 3, because the following groups had significant gaps between the highest student group's graduation rate and other student group rates. Specifically, every student group was below the students with disabilities student group in their 4-5 year graduation rate. There was a significant difference of about 4-20 percentage points for our homeless student group and English learners when compared to the All student group. Additionally, our socioeconomically disadvantaged, English learners, and Hispanic

students had a gap of about 11-20 points from the highest student group. This data shows that there are inequities in performance and our LCAP with its CSI plan is designed to address them in a comprehensive manner with research-based strategies such as intensive tutoring.

We are a charter school, and as a single school LEA, and our State and Federal Program coordinator provided support by discussing with school leadership to do the resource inequities and analysis, and agreeing to increase the funding for LCAP Goal 1 Action 3. The guiding framework was from The Alliance for Resources Equity at www.educationresourceequity.org. We also used the Dimensions of Resource Equity – School-level Diagnostic Questions, to determine key resource levers than create equitable learning experiences for all students.

Additionally, the inequities rubric, provided by the Los Angeles County Office of Education, was used to help identify if there were any barriers to the following:

- Access to Highly Qualified Teachers
- Access to Counselors
- Access to Student Retention Services
- Access to Tutors
- Access to Interventions both social-emotional and academic
- Access to Incentives for attendance, graduation, and retention
- Access to Support for high needs English learners, foster youth, special education, homeless
- Access to Technology and instructional materials

The resource inequities are being addressed by increasing the funding in LCAP Goal 1 Action 3 for intensive tutoring. This goal provides funding for the tutoring support that will be provided to students as the action is implemented at the school site. Students are identified for tutoring based on NWEA diagnostic results, teacher referral, and self-referral. Tutors connect with students daily and provide academic support in math and other subjects to help students learn and earn credits towards graduation.

All students receive a personalized learning program that is unique to each student and is specifically designed to create an optimal path toward graduation. The independent study model assigns a supervising teacher to each student, who develop a close relationship with the student, supports the student from enrollment to graduation, and brings in resources and support staff as needed.

Furthermore, the framework for guiding our process was based on Improvement Science in Education from the Carnegie Foundation for the Advancement of Teaching (2015). The Plan, Do, Study, Act (PDSA) model, when done frequently and in collaboration with a network will

help our school improve its outcomes on multiple metrics. Through our professional network, we used a fishbone protocol to determine root causes behind the conditions and drivers that lead to the outcome of a graduation metric. This helped us to define the problem we would like to address. Our discussion focused on what changes we wanted to introduce and why. We plan to collect and share data regularly around credit completion, attendance, and senior graduation progress to help answer the question: "How will we know which change is an actual improvement?"

The Six Principles of Improvement from the Carnegie Foundation helped provide a foundation for our analysis:

- 1) Make the work problem specific and user-centered: What specifically is the problem we are trying to solve?
- 2) Variation in performance is the core problem to address: What works, for whom and under what set of conditions?
- 3) See the system that produces the current outcomes: What are the drivers that yield change?
- 4) We cannot improve at scale what we cannot measure: What are the key outcomes that track progress?

5) Anchor practice improvement in disciplined inquiry: How will we engage in rapid cycles of Plan, Do, Study, Act (PDSA)? "How will we know which change is an actual improvement?"

6) Accelerate improvements through networked communities: How can we accomplish more together?

These guiding principles will be utilized in our professional network throughout the year as we meet to discuss progress and next steps.

Monitoring and Evaluating Effectiveness

A description of how the LEA will monitor and evaluate the plan to support student and school improvement.

The State and Federal Programs coordinator will support the school team and work with them in monitoring and evaluating the effectiveness of their improvement plan throughout the school year.

The process, including metrics, used for monitoring the implementation of the CSI plan is that the State and Federal Programs coordinator will collaborate with the school team to collect tutoring participation and share with teachers and school leadership.

The process, including metrics, used for evaluating the implementation of the CSI plan is to pull tutoring participation counts every learning period and determine if there is an increase in those who have received tutoring. The target is to increase tutoring participation by 50% at the end of the 7th learning period.

The process, including metrics, used for monitoring the effectiveness of the interventions to improve student outcomes is to pull and analyze credit completion for all students who participated in tutoring. This will be done every learning period.

The process, including metrics, used for evaluating the effectiveness of the interventions to improve student outcomes is to analyze the credit completion data to determine if it's increased. The target for the credit completion rate is 4.0. Additionally, we expect that the graduation rates will increase by at least 1% each year.

Additionally, we will collaborate with our professional learning community network and implement the Plan, Do, Study, Act (PDSA) model as our process for continuous improvement. Through a collaborative team of school educators, we will use school data, such as tutoring participation, credit completion rates, attendance, and graduation rates to inform our inquiry and help focus on results. By monitoring our evidence-based interventions, we can see how seniors and others are utilizing the one-on-one tutoring and social incentives for good attendance. We will also continue to monitor our key metrics, such as credit completion rates and NWEA results, to identify the needs of struggling students who could benefit from additional one-on-one tutoring.

Again, the measure of success for the plan will be based on key indicators such as credit completion, attendance, tutoring contacts, the DASS one-year graduation rate and the federal 4-5 year graduation rate. Since each student is assigned one-on-one time with an individual teacher all students who are identified in the system as 12th graders are monitored closely by their teacher for progress towards graduation. In addition, counselors monitor all seniors for credits earned. We plan to monitor students early and often so that we can be proactive in responding to student academic needs. We can build the capacity of our teachers and tutors so that they are able to do this. We also plan to do the following: provide support staff to work with students falling behind on a regular basis to address their specific needs; ensure that students in need participate in tutoring with a tutor they can connect to regularly; and promote participation in small group instruction when possible.

To help ensure that we have the whole school community mobilized to support our Comprehensive Support and Improvement plan, we will report results back to teachers, students, parents and the school board. We will share our progress on our CSI plan at least twice a year. We can build the capacity of our Parent Advisory Committee (PAC) and English Learner Advisory Committee (ELAC), by sharing the school data progress with them at their meetings and eliciting their feedback as part of our PDSA model. Our school board learns about student progress towards graduation on a regular basis, but with the CSI plan in place, we will ask for their feedback and input as part of our process. We have regular data reports that we can share out with student and parent groups throughout the year, and we will continue to collaborate and celebrate as students make progress towards graduation.

Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

Vista Norte Public Charter (VNPC) is in its second year of receiving Title 1 funds and we are using the LCAP as our School Plan for Student Achievement (SPSA). We are adhering to federal guidelines for involving our educational partners in the needs assessment, parent compact, parent and family engagement policy, and input into the direction of the federal program funding. We held our Title 1 Meeting on February 23, 2023 and shared student performance gaps and discussed how the federal funds could help by offering tutoring focused on literacy support. Throughout the year, we met to discuss student needs and how the funds could be appropriately directed to help improve student performance. Their input was incorporated into this LCAP.

Title 1 Annual Parent Meeting on this date:

• On 2-23-2023, VNPC held PAC meetings with parents, students, and staff to discuss our Title 1 program, student eligibility, and provision of tutoring services for our students. We presented the Title 1 program two times with our families to elicit additional feedback from parents and students.

Comprehensive Support and Improvement Collaborative Meetings on this/these dates:

 On 4/26/2023, VNPC held a PAC meeting with parents, students, and staff to share the upcoming Comprehensive Support and Improvement (CSI) designation of the school. CSI was discussed and the attendees were given an opportunity to share concerns and ask questions.

To meet our LCAP Parent Engagement goal this year, VNPC held numerous meetings to share information about the school and also ask for the feedback of parents and students. The meetings were scheduled in advance and communicated to parents and students through multiple avenues: text messages, online school messaging platforms (L4L Connect, Remind, TextNow, etc), emails, phone calls, and in-person discussion. Our educational partner groups included parents, teaching staff, support staff, administrators, students, school counselors, community partners, and others. As part of our annual educational partners feedback loop we distributed a survey to staff, students, and parents. This survey asks for feedback in multiple domains, ranging from the school climate to curriculum and social-emotional well-being.

We believe that many of the improvements in the school program are a result of how we elicited feedback from students, parents, guardians, teachers, administrators, and community partner groups. We also extended the window for feedback compared to prior years so that additional time was available for feedback. Input from our local SELPA was sought and shared with parents of students that have special needs. VNPC scheduled schoolwide meetings throughout the school year and presented the progress of our LCAP and grant funding to the participating members at those events. Some of the events include (but were not limited to) Back to School events, Open Houses, quarterly-held ELAC and PAC meetings, Student Award Nights, and Parent/Teacher conferences.

VNPC used every engagement opportunity to inform educational partners of the school's progress and about the school's LCAP goals. At every meeting school leadership shared state and local assessments including up-to-date summative and formative assessments highlighting progress in student achievement and areas of improvement. We also shared the process of our English learner (EL) population and their successes in Reclassifying as Fluent English Proficient (RFEP). Substantial discussions occurred at several of these meetings over what might impact student learning and affect the graduation rate of seniors, and also school events or field trips that may be interesting or beneficial to the student population. School leaders also shared the actions that were implemented to achieve the school goals. In addition, parents were given information on graduation requirements and college/career readiness by school counselors.

During our meetings we shared our current CTE Pathways, dual enrollment progress, and past/current student events and opportunities. English Language Learner staff shared the importance of ELPAC testing and English learner reclassification, and placement process along with the number and percentage of students being redesignated compared to Statewide averages. Site leaders discussed enrollment, enrollment retention, and shared changes to the school budget under local control; parents were also asked for consultation about the school LCAP goals and, actions and services. Input from parents was documented and shared with school staff to get a better sense of the needs of students and parents. The School Survey was available from January 2023 through February 2023 to all educational partners. These surveys were another means to gather input from individuals who were not able to provide feedback at one of our meetings and gather additional input. From these meetings and surveys, VNPC was able to evaluate the concerns and needs of the community helping us to adjust our program, increase student success, and increase parent communication.

Listed below are the details of the process: Comprehensive Needs Assessment meetings' target audience included district administrators and site administrators. Administrators reviewed data aligned with the metrics to determine if progress was being made in achieving desired outcomes. PAC and ELAC meeting agendas included data as it became available locally and through the state (e.g., Dashboard data). Data analysis included a broad overview of reviewing aggregate data to determine areas of progress and/or concern. Follow-up meetings included a deeper dive into the data by reviewing student detailed reports.

This school year, VNPC held English Learner Advisory Council (ELAC) meetings. Meetings were held on the following dates:

- 9-1-2022 ELAC Meeting: Advisement of ELAC's purpose, Review of Responsibilities, Staff introductions, SGI class offerings, Testing for ELPAC, Nominations of ELAC Officers, Scheduling of Upcoming Meeting.
- 9-9-2022 ELAC Meeting: Advisement of ELAC's purpose, Review of Responsibilities, Staff introductions, Housing and Urban Development (HUD) form, Nominations of ELAC Officers, Scheduling of Upcoming Meeting.
- 11-17-2022 ELAC Meeting: Advisement of ELAC's purpose, Review of Responsibilities, Staff introductions, SGI class offerings, Testing for ELPAC, Nominations of ELAC Officers, Scheduling of Upcoming Meeting.
- 12-9-2022 ELAC Meeting: Review of ELAC's purpose, staff introductions, FAFSA workshop share-out, EL reclassification steps, SGI classes offered, upcoming testing, sharing of VN's EL and Title 1 plans, review of ELAC bylaws, Scheduling of Upcoming meeting.

• 2-7-2023 - ELAC Meeting: Counselor update regarding graduation, EL reclassification update, current SGI class offerings, California state testing update, Scheduling of Upcoming Meeting.

Engagement with Students:

• Students are on our PAC and on 4-4-2023, they were asked for their consultation into the LCAP and CSI plan. They supported the actions for tutoring, as well as snacks and nutrition.

Engagement with Principals and Administration:

Administration regularly engages in the data related to school progress. On 4-3-2023, LCAP related data like the CA Dashboard was
discussed. On 4-19-2023, the CSI status was discussed along with the LCAP Annual Report. The administration is in agreement on
the LCAP Goal 1 Action 3 for tutoring as a means to improve the graduation rate.

Engagement with Teachers:

- 12-1-2022 Professional Development regarding student retention
- 2-10-2023 Professional Development with Alex Sheen regarding social-emotional support for students
- 3-22-2023 Participation in multi-day CABE (California Association for Bilingual Education)

Teachers, staff, and administration met for professional development throughout the school year. Agendas for the meetings varied by School Principal but topics included: LCAP goal updates, LCAP budget updates, Title 1 Needs Assessments, Statewide Test requirements and participation percentages, Social-Emotional and Trauma-Informed best practices, strategies for support of unduplicated student groups such as foster youth/low-income/special needs/students with disabilities, and curriculum updates. The meetings included a number of different feedback opportunities through multiple collaborative activities (gallery walks, polls and surveys, small- and large-group conversations, and others). Meetings were held on the following dates:

- 7-1-2022 Three professional development in-service days (7-1, 7-5, and 7-6)
- 12-1-2022 Professional Development regarding student retention
- 1-3-2023 Four professional development in-service days (1-3 to 1-6)
- 2-10-2023 Professional Development with Alex Sheen regarding social-emotional support for students
- 3-13-2023 California Charter Schools Association 4-day conference
- 3-22-2023 Participation in multi-day CABE (California Association for Bilingual Education)

Vista Norte Public Charter does not have a Certificated or Classified bargaining unit at this time.

In May 2023, a draft of the LCAP was posted on the Vista Norte Public Charter website for two weeks and made available for public comment. The public was provided the opportunity to call or email the principal and provide their input during this time. No input was received on the LCAP draft.

Our school board met in May and reviewed the LCAP data and discussed the actions of the LCAP. They support the development of the LCAP and our goals. We had our public hearing on June 7, 2023, and our school board approved the Local Control and Accountability Plan on the day. Board approved the Local Indicators at the same meeting as the LCAP. The Board adopted the budget at the same meeting of the LCAP Adoption.

SPECIAL EDUCATION SELPA SUPPORT:

We have a good partnership with our SELPA administration and the following collaborative activities have had a positive impact:

* The El Dorado Charter SELPA participates and provides guidance in the CDE's Special Education Monitoring Processes

* The El Dorado Charter SELPA provides program and technical support by the Program Specialist and/or other SELPA team members.

* Dropout (and Graduation) data for special education students are reviewed in a collaborative process with the El Dorado Charter SELPA.

* Staff training related to special education students is provided by the El Dorado Charter SELPA as needed and requested.

* The SELPA Program Specialists were provided a copy of the LCAP for consultation on the alignment of LCAP activities with the annual assurances support plan.

A summary of the feedback provided by specific educational partners.

Here is the summary of Vista Norte Public Charter's educational partner feedback:

Parents' Feedback:

During the PAC meetings, parents asked about additional social-emotional and counseling support for students. In addition, parents praised the one-on-one support and available tutoring for students. They cited positive staff-student relationships as a key to students' motivation to graduate.

Parents' CSI Feedback:

Parents provided feedback during the May 2023 PAC and ELAC meetings. Here is a summary of their feedback:

- Additional tutor/paraprofessional support on campus
- Continued mental health support and workshops for parents and students.
- Continued School Counselors and Social Workers collaborating to facilitate social-emotional supports and groups based on student needs

• Increase workshops to help parents better understand the financial aid process, different grants, and the college readiness process

Student Feedback:

• Students shared that they appreciate the school providing extra curricular activities to keep them engaged in school. They enjoy attending extracurricular activities and field trips. The snacks and nutrition provided throughout the day are well received. Students also liked that the school offers sports and experiential learning.

Student CSI Feedback:

• Students feel supported by the school community. They indicated that the support of their teachers and tutors are integral to their success.

Administration Feedback:

 School leadership reported the importance of incorporating positive recognition of academic and social achievements and milestones to increase attendance, engagement, and academic performance. Leadership agreed to continue the increased efforts for EL Learners through targeted support and interventions. School leaders agreed on strengthening the CTE and Dual Enrollment actions.

Administration CSI Feedback

• School leaders agreed that one-on-one tutoring support will support the CSI plan to improve the graduation rate. In addition, academic planning and support from school counselors will improve the number of graduates.

Teachers Feedback:

• Staff continue to express the greater continued social-emotional support and strategies for motivation. In addition, one-on-one intensive tutoring was discussed as an effective method to support students' increased credit completion. Staff like the focused events, activities, and support of seniors to graduate.

School Board Feedback:

• In April, we presented the board with the LCAP metrics and Goals and they were in support of the LCAP Goals and Actions.

Public Feedback:

• The public was provided the opportunity to call or email the principal and provide their input during this time. No input was received.

Vista Norte Public Charter will continue to collaborate with educational partners throughout the school year to explore and monitor the progress of implemented actions. Educational partners were supportive of maintaining the goals and actions intended to provide services to

all students and actions intended to provide services to English learners, foster youth, low-income students, and students with exceptional needs. All goals and actions will be continued and monitored. Tutoring was identified as the primary method to support the CSI Plan implementation.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

Graduation rate and methods to improve Vista Norte Public Charter's graduation rate were put forth to educational partners at staff PLC meetings, Parent Advisory Committee (PAC) meetings, and English Learner Advisory Committee (ELAC) meetings. Conversations between school staff (including counselors, social workers, and student retention support staff), students and educational partners are held on a continual basis. Senior events and information nights are held throughout the year to seek input directly from students and parents of students who are close to graduating. Additionally, we will gather input from annual parent and student surveys as well as student graduate surveys and exit surveys.

Input gathered from Educational Partners include the following:

- Parents at the ELAC and PAC meetings discussed the CSI status and supported the plan to increase tutoring supports, to help improve the graduation rate. This input is reflected in Goal 1 Action 3.
- Parents find senior parent meetings and events to be valuable and would like to continue having them on a regular basis, multiple times annually.
- Parents find the one-on-one support from teachers and counselors important and beneficial and would like more opportunities weekly for one-on-one counselor support.
- Parents like that their students are receiving college and career support, including support with financial aid and resume building.
- Parents appreciate the community resources offered to their students.
- Students suggested that an increase in tutoring would be appreciated and could help improve the graduation rate. In the CSI plan and in Goal 1 Action 3, their consultation has been included in the action for tutoring supports.
- Students enjoy the senior events offered and would like more frequent "large-scale" events like a "grad night."
- Students find value in goal setting and personalized learning plans.
- Staff (teachers and support staff) provided input into the CSI plan and agreed that an increase in tutoring would be a good idea. Their support for tutoring is a reason why Goal 1 Action 3 is written into the LCAP.
- Graduate and Exit Surveys indicate graduates felt supported by staff and appreciated the flexible, one-on-one, personalized model. The surveys also indicate that graduates felt like they could utilize more support in computer skills, organizational skills, and career planning.
- Staff appreciate the tracking and support of seniors by the counselors and social workers.
- Staff appreciate the collaborative team approach to support seniors.
- Staff would like to see a formalized process to support seniors after graduation.

Goals and Actions

Goal

Goal #	Description
1	Increase Academic Progress:
	This is a focus goal for increasing academic progress for all students, especially our English Language Learners, low- income and foster youth, who struggled during the previous year. In the next three years, we will have mitigated the negative impact learning loss had on our students, and we will see improvement in our NWEA, EL reclassification, credit completion and graduation rates.

An explanation of why the LEA has developed this goal.

As a result of our CSI status and our analysis on key state and local data, we determined the need for a focus goal on academic performance for all of our unduplicated students. This new goal specifically addresses low key metrics such as the English Learner reclassification rate, credit completion, and graduation for our student groups. We looked at our student group data, which reveal performance gaps between the "All" Student Group, and the unduplicated students. Our students also take the NWEA MAP assessment, and we measure academic growth from year to year in this way. This year, performance gaps among student groups were also revealed, using that assessment. We understand the gaps that need to be closed for our students, and this focus goal was carefully designed to support their academic needs with targeted interventions and tutoring.

We sought the consultation of our educational partners, and involved them the LCAP process, which we believe promotes positive engagement, buy-in and trust. We know that additional tutoring, interventions, and counseling support will help address the learning loss over the next few years.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

Overall, we were able to implement the actions in this goal and there was no substantive difference in planned actions and actual implementation of these actions.

Action 1 - English learners support staff, interventions, and materials: We were able to implement this action and there was no substantive difference in planned actions and actual implementation of these actions. Vista Norte employs numerous English learner support staff which include bilingual teachers and tutors. We also purchased curriculum and software licenses to support the academic growth of our English learner student population.

Action 2 - All academic interventions and program materials: We implemented this action by providing intervention support including SGI's with Teacher instruction and support. We increased our NWEA test participation so that we could more clearly identify growth areas for students. Analysis of the results allowed for targeted support via SGI. We were also able to identify sub-populations of students for additional support.

Action 3 - Tutoring and supports for students: All of the items in this action were able to be implemented this year by fulfilling the tutoring program components with Tutors and tutoring supports. Vista Norte utilized LCAP funding to support the hire of additional support staff to aid student academic growth, including paraprofessionals and tutors. We also utilized both on-site and remote instruction for academic support.

Action 4 - Counseling students towards graduation and materials: We were able to implement this action and there was no substantive difference in planned actions and actual implementation of these actions. VNPC was able to improve our student to counselor ratio this year, which allowed for additional support as students progressed toward graduation. Counselors held career professional opportunity onsite, such as military enlistment presentations, local career professionals from the surrounding area who shared their successes, and also experiential learning trips to colleges.

Action 5 - Student activities that increase learning efforts: We implemented this action by providing student activities that increase learning efforts such as field trips and enrichments activities. VNPC students participated in numerous college and career opportunity field trips. The experiential learning field trips served to encourage students to look beyond high school at potential career opportunities and post-secondary education. We expanded our eSports gaming program across both of our school sites and began competing in competitive gaming competitions against other schools in California.

Action 6 - Teachers and staff are qualified and appropriately assigned: There were no substantive differences in the planned action compared to the actual implementation. We utilized LCAP funding to support the hiring of teachers that left our school throughout the school year. Our staff retention is paramount as we believe that strong relationships with students lead to success, but when staff members left we were able to replace them with a highly qualified teacher or appropriate equivalent.

Action 7 - Title 1 – Intervention programs and personnel to support students: All of the items in this action were able to be implemented this year by having teachers, tutors, and paraprofessionals focused on literacy support for students. Hosting SGI classes for students aided in the academic supports for all students, including our English learners.

Action 8 - Professional Development for English learners: We were able to implement this action and there was no substantive difference in planned actions and actual implementation of these actions. Our English learner teachers and tutors were encouraged to participate in trainings targeting our EL population, including the California Association for Bilingual Education conference.

Overall Successes: Our school was able to support students with targeted interventions through one-one-tutoring and small-group instruction. This led to a continuation of our success rate, which is 90.68%, and reflects the number of students that graduate with us or return to their local school district. Our attendance rate also increased to 90.68% this year. We were able to provide more structured and targeted professional development through review of student data and assessing areas of support that would most greatly support our staff

and student outcomes. We also bolstered our English learner supports with the designation of an English learner Lead Teacher and professional development for staff that provide instruction and support for our English learners.

Overall Challenges: Our school was challenged by supporting students to transition back to fully in-person learning while addressing trauma, social-emotional concerns, and learning loss. In addition, some staffing positions have been difficult to fill. For example, we attempted to hired a school social worker but were unable to fill that position so we hired an additional counselor instead. Our English learner reclassification rate remained at 2.0% and we are increasing our tutoring supports to improve that metric. Our average scaled scores on NWEA tests dipped slightly but that may be due to our increased enrollment and focus on regular testing.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services; because actual expenditures were approximately the same as budgeted expenditures and principally directed towards our English Language learners, low-income, and foster youth students. We were able to meet our budgeted expenditures as shown in the 2022-2023 Contributing Actions Annual Update table for estimated actual expenditures. This is true for the LCFF funds. There was a positive material difference, due to the actual allotment of \$160,322 in Title 1 funds, which were used to support actions in Action 7.

An explanation of how effective the specific actions were in making progress toward the goal.

Overall, the combined 8 actions of this goal have increased the academic progress of our students as measured by key metrics such as the graduation rate, credit completion rate, and English learner reclassification rate (or use NWEA). As shown above, in the Measuring and Reporting Results chart, the graduation rate increased by 2 percentage points, to be 82.7%. This is the result of a comprehensive and strategic approach to helping students complete their coursework and earn credits towards graduation. Our credit completion rate was lower than last year at this time. Our intervention programs and tutors should be able to help us realize an increase in our credit completion rate next year. We are constantly focused on helping our English learners and their reclassification rate improved. Although our ELPI showed low growth, we are constantly focused on helping our English learners and their reclassification rate improved. The improvement shown in EL reclassification, credit completion, and the graduation rate show that we met our goal for increasing academic progress.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

As a result of reflection on prior practice, and due to our CSI status, we selected intensive tutoring as our research-based strategy for our CSI plan, and it is reflected in Action 3. Other changes were that there was no calculation for the English Learner Performance Indicator for 2021, so we reported ELPAC Levels 1-4 as a placeholder to show that we are examining the data that is available for our English learners. This year we have the 2022 ELPI results, and the levels were removed. The ELPI becomes available on the CA Dashboard and it is reported this year. Secondly, we were reporting RIT scores for NWEA Reading and Math results, and now we are reporting Lexile scores for reading and

quantile scores for math, because that aligns with how scores are reported at a national level. We did this in order to be more comparable with other DASS schools.

The actions outlined in Goal 2 supported the progress in meeting the following goal: VNPC Students will Gain Skills for College and Career-Readiness.

Action 1 - Career and college-readiness for English learners, low-income and foster youth students: We were able to implement this action and there was no substantive difference in planned actions and actual implementation of these actions. Vista Norte Public Charter

maintained support and focus this past year on career readiness and 100 students completed our Professional Skills career readiness course.

Action 2 - Professional development addressing English learners, low-income and foster youth students: We implemented this action by providing professional development and conference opportunities for staff. We participated in both regional and targeted trainings, especially for our counseling team.

Action 3 - Technology Access & Support: All of the items in this action were able to be implemented this year by providing technology, materials, and software for student learning. Vista Norte employs staff to support the school's technology program and this goal and action. VNPC has invested heavily in technology over the past few years with student technology being a key focus of our academic support, both through Chromebook computers and WiFi hotspots for students to access their courses remotely.

Action 4 - Support for Standards-based Curriculum and Instruction: We implemented this action and there was no substantive difference in planned actions and actual implementation of these actions. The school regularly orders curriculum, software licenses, or other standards-based items that support instruction.

Action 5 - Educational materials for an effective program: We were able to implement this action and there was no substantive difference in planned actions and actual implementation of these actions. Vista Norte maintains a library of educational resources at each resource center location and ordered any additional materials necessary to support academic instruction across our educational program.

Action 6 - Safe and secure facilities: There were no substantive differences in the planned action compared to the actual implementation. Our facilities continued to be maintained in exemplary condition via safety inspections and needed repairs throughout the school year.

Overall Successes: Our school was able to expand our Dual Enrollment and CTE offerings for students. Our school continued to have strong participation in the Professional Skills course with 100 students completing the course this year. We also provided technology support for students such as Chromebooks, WiFi hotspots, and instructional software to support learning. Staff professional development addressing English learners, low-income, and foster youth students was a focus this year and we spent more than was allocated in that action. Another success was our SGI courses, as students benefitted from small group instruction with their teacher.

Overall Challenges: Our school continued to struggle with CTE pathway completion. While our dual enrollment participation numbers have begun to increase, we found that 43.75% of our students completed a CTE pathway this year. Our school's A-G course completion is below our goal. Lastly, CAASPP Math and English proficiency levels increased in some demographics but the amount of growth across assessments reflect that we are as a still in the "Very low" performance band on the School Dashboard.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services; because actual expenditures were approximately the same as budgeted expenditures and principally directed towards our English Language learners, low-income, and foster youth students. We were able to meet our budgeted expenditures as shown in the 2022-2023 Contributing Actions Annual Update table for estimated actual expenditures.

An explanation of how effective the specific actions were in making progress toward the goal.

We effectively implemented our College and Career-Readiness goal, as measured by key metrics, such as participation in CTE and Professional Skills courses, a standards-based curriculum, and the California Assessment for Student Performance and Progress. Our English learners, low-income, and foster youth students were able to engage in activities that focused on career-readiness and/or college readiness. Our seniors completed the A-G requirements at 4.91%, which is good for a program like ours. Professional skills courses had an enrollment of 100 this year. 100% of our students had access to a broad range of courses. The results from last year's CAASPP test was 19% in ELA and 6% in Math. We were able to implement our college and career-ready, standards-based instructional program this year. Additionally, we ensured that students had access to technology and a high level of connectivity in order to support their learning efforts.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

With the release of the CA Dashboard calculations for status in English Language Arts and Mathematics, we added the metric to Goal 2 Action 2, as it aligns with the CAASPP results. In the previous year, we added a metric for seniors who completed a CTE pathway and graduated completing the A-G requirement. We will continue to implement actions towards the achievement of Goal 2 as planned.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

The actions outlined in Goal 3 supported the progress in meeting the following goal: VNPC will Increase Student Retention.

Action 1 - Student Retention: All of the items in this action were able to be implemented this year by providing meaningful school activities for educational partner participation. Vista Norte Public Charter School employs Student Retention Support (SRS) staff to support our students who are struggling to complete credits, attend school regularly, or balance their personal obligations with graduation progress at school. We utilize trauma-informed practices to meet the needs of our students from multiple points of support and the SRS collaborates with administrators, teachers, and other employees to help our students.

Action 2 - Social and Emotional Supports: There were no substantive differences in the planned action compared to the actual implementation. VNPC supports our students' social-emotional health by increased services from our counseling teams. We also participated in social-emotional professional developments with staff and counselors this year that paired with our trauma-informed best practices.

Action 3 - Access to Transportation: The school was able to implement the action as planned. We were able to participate in two experiential learning field trips this year, one to San Diego and one to Sacramento. During those trips, students visited colleges and other venues that helped expand their academic and career horizon.

Action 4 - Access to Nutrition: VNPC implemented this action and there was no substantive difference in planned actions and actual implementation of these actions. We provided food for students at the school sites in the form of snacks and hot food at student events, and on field trips.

Action 5 - Title 1 – Helping Homeless: No substantive differences occurred in the planned action compared to the actual implementation.

Overall Successes: VNPC was able to provide student events and activities around student wellness, retention, and socialization. We also purchased self-care items for students in our homeless and foster youth population, such as deodorants and other hygiene products, cold-weather clothes, and non-perishable food. Student home visits increased to support students which resulted in an increased success rate (90.68%) which measures the percentage of students that graduate with us or return to the home district school, and also a decrease in our dropout rate (7.3%). VNPC was also able to provide student nutrition to English learners, low-income, and foster youth students via snacks and food at the school sites and also non-perishable items that they could take home.

Overall Challenges: Our school continued to face steep challenges presented by the wide scope of student social-emotional and mental health needs stemming from the pandemic and readjustment to in-person learning. In addition, some local changes to the transportation agency's policies to student riders affected our implementation of student transportation. We failed to meet our Action 3 expenditure goal. We will continue to reassess student transportation needs on an ongoing basis.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services; because actual expenditures were approximately the same as budgeted expenditures and principally directed towards our English Language learners, low-income and foster youth students. We were able to meet our budgeted expenditures as shown in the 2022-2023 Contributing Actions Annual Update table for estimated actual expenditures.

An explanation of how effective the specific actions were in making progress toward the goal.

Overall, we have increased the retention of our students as measured by key metrics, such as the success rate, retention rate, and low dropout rate. As shown above, in the Measuring and Reporting Results chart, the success rate increased by 0.4 percentage points, to be 92.6% in 2023. This is the result of a comprehensive and strategic approach to helping students remain engaged in their education and help them overcome barriers to learning.

Our efforts to re-engage students resulted in an increase in our retention rate to 89.9% this year. The non-completer/dropout rate this year is 7.3%, which is an improvement from last year. Additionally, the attendance rate is above what it was last year, and is now at 90.68%. These metrics show that we have improved retention and that the actions are effective in this goal.

Action 1 - Community/Parent Liaison and Meaningful School Activities: All of the items in this action were able to be implemented this year by providing meaningful school activities for educational partner participation. Vista Norte employs a community liaison whose primary role is to support outreach into the community on behalf of the school. The school also hosted numerous school site events this year to encourage parents to visit the school and connect with staff and students, such as Back to School Nights, awards assemblies, and parent engagement meetings.

Action 2 - Translation and Outreach Services: There were no substantive differences in the planned action compared to the actual implementation. We were prepared to (or utilized) translation services during our PAC and ELAC meetings and any other meeting where services were needed. Our PAC and ELAC agenda were also shared in both English and Spanish so that both native and non-native speakers could participate and give feedback.

Action 3 - Educational Partner Engagement: No substantive difference occurred in the planned action compared to the actual implementation. VNPC utilized LCAP funding to support outreach into the community through the provision of transportation, food, or other services necessary to increase parent and community participation in school events.

Action 4 -Title 1 – Parent Engagement: We were able to implement this action and there was no substantive difference in planned actions and actual implementation of these actions.

Overall Successes: Our school was able to obtain substantive and actionable feedback from educational partners with surveys, PAC/ELAC meetings, and during school activities. These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
