- II. Welcome/Introductions: Introductions, Memo Velasco Principal. Jesse Taylor Learning Center Coordinator, Raquel Goyenaga Parent Engagement Liaison, Martha Vasquez School Counselor.
- III. Title I Program Evaluation is quantitative data that we use to drive instruction, and it is what we use to evaluate our program. With that said here is the quantitative Evaluation of LCAP Goal 1 Action 7: Title 1 – Intervention programs personnel to support students. Federal funding has been directed to hire Literacy teachers who will implement research-based educational strategies. When doing so the data showed that there was a 21.22% average Lexile Percentage Growth from test 1 to test 2 in the 22-23 school year. What didn't work and why? According to feedback from teachers and students 156 intervention credits were completed by 14 TAS students as part of the literacy interventions and academic courses. We met our goal! Because of the outcomes we will continue to offer interventions and increase student engagement efforts to increase student participation.

LCAP Goal 4 Action 4: Title 1 – Parent Engagement. Federal funds are directed at meaningful parent events to support activities such as food, transportation, and other meeting materials. What is currently working is providing documents in the parents native language, sign in sheets, agendas and having minutes complete. The evidence show a total of 77 participants for 22-23 school year. 53 parents completed the Annual Survey, 81.13% of parents/guardians feel encouraged to participate. What did not work, was holding ELAC meetings virtually and in person, it shows as ineffective, because full participation in the annual survey was not reached. In the future we will make sure to have different times for the meetings for ELAC and PAC, but will continue to reach out to more parents through a variety of methods.

IV. Reclassification:

What is reclassification? Reclassification is when a student tests out of English Language Proficiency Assessment for California, otherwise known as ELPAC. When a student receives a 4 overall on the ELPAC the student must also have a completed course of English or English Language Development of 5 credits to be eligible for reclassification. The student must also reach a Lexile range of 850L or in between the range of 850L to reclassify. The goal for every student is to help them achieve English Language Proficiently. One very important thing parent must know is that we get NWEA Lexile scores and every single student at our school is taking this NWEA test. Please encourage your students to do their best when they let you know they're coming in to test on NWEA. Congratulations to the five students who reclassified this school year. They are now English Proficient.
